The NZ Transport Agency and ViaStrada are offering a one-day industry training course focussing on planning and design for cycling, based on the recently ratified *Cycling Network Guidance* and cycling levels of service research. The course will benefit anyone involved in planning or designing for cycling facilities such as: project managers, road safety auditors, transport planners, transport engineers, advocates and elected members.

The course will summarise recent advancements in cycling planning and design understanding, using case studies from a wide range of New Zealand projects implemented in the last five years.
